Mr. In Ho Lee is a Senior Advisor at Shin & Kim and Professor Emeritus of Economics at Seoul National University. He provides advisory services based on economic analysis across various fields, including antitrust and financial policy and regulation.

Over his 30-year career, Mr. Lee taught game theory, microeconomics, and financial intermediation theory at institutions such as the University of Southampton and Seoul National University. He has been recognized for his outstanding research in game theory, receiving the Dasan Economics Award, Maekyung Economist Award, Chungang Thesis Award, and Cheongnam Award.

He has demonstrated exceptional expertise in landmark cases considered milestones in Korea's antitrust enforcement history, including global IT company's bundling case, global semiconductor company's loyalty rebate case and global telecommunications equipment company's royalty discrimination case, serving as the economic analyst for the Korea Fair Trade Commission. In recognition of these contributions, he was awarded the Order of Service Merit (Red Stripes) by the Korean government in 2021.

Mr. Lee has also advised the President as Vice Chairman (ministerial level) of the National Economic Advisory Council and provided guidance on financial policy and regulation as Chairman of the Financial Development Deliberation Committee under the Financial Services Commission. Drawing on this experience and authority, he currently offers practical and expert advisory services to corporations and institutions in the fields of antitrust, finance, and digital finance.
