During his public service, he gained extensive experience across the full spectrum of labor administration, including labor inspections, labor-management relations, occupational safety and health, employment policy, and labor relations commission proceedings.

In particular, Mr. Kim conducted workplace inspections and regulatory supervision relating to occupational safety and health, investigated serious industrial accidents, and handled a broad range of individual employment matters, including wage claims, workplace harassment, and sexual harassment cases. He also carried out labor inspections concerning compliance with labor standards legislation and illegal dispatch arrangements, developing extensive practical experience in the enforcement of labor and employment laws.

Mr. Kim also advised on and supported collective bargaining and the execution of collective bargaining agreements, handled unfair labor practice cases, and worked on the prevention and resolution of labor disputes. In addition, he was responsible for mediation proceedings before the Labor Relations Commission and administrative litigation involving unfair dismissal and unfair labor practices, providing him with substantial expertise in collective labor relations and labor dispute resolution.
