He is on the KCAB's Panel of International Arbitrators, Vice Chair of the Korea Council for International Arbitration (KOCIA), a member of the Management Committee of the Seoul International Dispute Resolution Center (SIDRC) and a member of the Commercial Arbitration Support-Committee of the Ministry of SME's Korea Federation of SMEs.
