He was also in charge of responding to investor-state dispute settlement (ISDS) cases filed against the Republic of Korea by corporations such as Companies L and E. In addition, at the Defense Acquisition Program Administration (DAPA), he served as Director of Legal Litigation and Director of Supervision and Support, where he provided legal advice on defense industry-related matters and oversaw related litigation.
