Thereafter, she served for approximately 19 years at the Constitutional Court of Korea as a Constitutional Research Officer and Senior Constitutional Research Officer, handling a broad spectrum of constitutional cases involving civil liberties, property rights, social rights, criminal matters, and exclusive jurisdiction matters. Ms. Kim also served as a Judicial Research Officer at the Supreme Court of Korea, where she reviewed major constitutional and administrative law cases.

In addition, Ms. Kim held various key positions at the Constitutional Court, including Planning and Coordination Officer, Head of the Exclusive Division, and Senior Constitutional Research Officer in the Preliminary Review Division dedicated to constitutional complaints against court decisions, thereby gaining extensive experience across all areas of constitutional adjudication practice. In particular, she possesses deep expertise in matters under the jurisdiction of the Constitutional Court, including constitutional complaints, adjudication on the constitutionality of statutes, competence disputes, and impeachment proceedings.
